## Amendment No. 1

### **Proposed by: International Board of Trustees**

Amend the WBCCI Constitution, Article XVI, Title: Amendments, Section 2 (page 8), by deleting the number "90", and inserting "a minimum of 80". Section 2 would then read as follows:

"Amendments to this Constitution may also be adopted by a two-thirds vote of the members represented by the Delegates present and voting at the annual Delegates Meeting voting in accordance with Article XII of the Constitution. Such proposed amendments may be submitted in writing by any chartered unit, by the Board of Trustees and by the International President. Any such amendment(s) submitted by a Unit shall bear a certification by the Unit President that it has been approved by a majority vote conducted in accordance with the Unit's Constitution and Bylaws. The proposed amendment(s) shall also bear a certification by the President of the Region of which the originating unit is a part, that the amendment has also been approved by a majority of the members of the Region Board of such region. Such proposed amendment(s) shall arrive at Headquarters by March 1. Headquarters shall distribute copies to the Presidents of all chartered Units by April 1 (a minimum of 80 days prior to the Delegates Meeting to which such proposed amendment(s) are to be presented, in order to give the units ample time to vote and instruct their Delegates).

### Report of the WBCCI Constitution and Bylaws Committee

As directed by the WBCCI Constitution, Article XVI, Section 3, this report is submitted by the Constitution and Bylaws Committee.

The Delegates reaffirmed at their June 30, 2014 Meeting that the period for holding the International Rally and Annual Delegates Meeting shall be between June 20 and July 30 (Article XII, Section 2 (page 6). Presently, the wording in Article XVI, Section 2, basically specifies the date of June 30 for the Delegates Meeting which has been the traditional date for many years. The intent of the amendment is to allow the Delegates Meeting any time within the June 20 to July 30 time period, thus making the provisions of Articles XII and XVI to be compatible and consistent, certainly not in conflict. The Committee reviewed other procedural possibilities, but in order to retain the 90 day period, each year the specified dates of Article XVI, Sections 2 and 3, would have to be pre-stated, resulting in confusion, inconsistency and unnecessary publication. Passage of this motion would preclude this and allow a period of between 80 and 120 days for units to review, vote and instruct their Delegates.

This Committee strongly recommends that this motion be approved. The IBT passed this unanimously.

### Amendment No. 2

### **Proposed by: International Board of Trustees**

Amend the WBCCI Constitution, Article IX, Title: Board of Trustees, Section 7 (page 4), by deleting the entire Section and insert a new Section 7 as follows:

"A member of the Board of Trustees shall hold only one Board of Trustee position at a time, but may hold other Region or Unit positions. Nothing herein contained shall disqualify an International Officer or Region Officer from service on Standing or Special Committees".

### Report of the WBCCI Constitution and Bylaws Committee

As directed by the WBCCI Constitution, Article XVI, Section 3, this report is submitted by the Constitution and Bylaws Committee.

Facts: The composition of the Board of Trustees is stated in the WBCCI Constitution, Article IX, Section 1, which includes the elected International Officers (including the Immediate Past International President) and all of the Region Presidents as voting members except the President which is limited by Roberts Rules of Order. This body is also the "directors" of the Corporation as defined by the Code of Ohio through which our organization, the WBCCI, is incorporated. Although Region Vice-Presidents are not members of the IBT, but receive certain region privileges, they are presently eligible for other duties as the proposed motion would also allow. Also for consideration is that a Unit President elected to Region Office may complete his/her term as Unit President (WBCCI Bylaws, Article IX, Title: Regions, Section 2.C, page 22).

The present Section 7 reads that "A member of the Board of Trustees shall hold no International, Region or Unit office or position other than that office or position which places him on said Board". Therefore, this amendment, if passed, would allow an International Officer and a Region President (already on the IBT) to serve in Unit office and positions.

Because the motion as written states "A member of the Board of Trustees....." which includes the International Officers, the WBCCI Constitution and Bylaws Committee does not recommend that this amendment be passed as written. If it had been written as Region Officers only, then it would have best be determined by the Delegates of the Units. It is noted that the IBT voted to refer this amendment to the Delegates, but by a split vote.
