Future of our Wisconsin Unit

The Wisconsin Unit has been in existence for nearly fifty-three years. Many members have served our unit over the years as officers, rally hosts, and in too many other ways to name. Forty-nine members served as President and, in the first few years, some individuals served for multiple years. A few families have had both spouses serve as President. Our unit is now facing a dilemma. Currently we have an open 1st VP, 2nd VP, and Trustee position. Also, the Treasurer graciously served for a fourth year because no one stepped forward to take over the duties.

In the last few years, two units in Region 7 have disbanded because they had low membership numbers and no officers. We currently have 87 members and have a very good balance sheet with a balance in excess of \$5,500. (See the Treasurer's report elsewhere in this newsletter.) The International Blue Book states that a unit needs to have ten members and officers to retain its charter. If not the, "unit may merge with another unit, consolidate with one or more units, or the unit may dissolve". This is the stark reality that the Wisconsin Unit faces if we do not replenish our officer ranks.

This problem was brought to light at the installation dinner in Sparta. Ellen McGaughey volunteered to help facilitate brainstorming and obtain Member input regarding the future of the Wisconsin Unit. We started with a discussion at the November luncheon that touched various aspects of the Unit and the viability issues it is facing. The Trustee -2^{nd} VP -1^{st} VP - President sequence is intended to provide on-the-job training for the eventual unit leader, but note that vice presidential succession is a tradition, not a requirement of the unit constitution.

Here's my own experience as newly-minted Unit President. I accepted when invited to serve as 2nd VP and really didn't do much except attend unit functions as usual and watch closely what the big kids were doing. Last year as 1st VP, Barb and I hosted the Green Lake rally (Bob Manak had reserved the site) and we had a blast! This encouraged us to scout the two rallies we will be hosting this year, and we discovered scouting rallies is as much or more fun than attending them. You will find campground owners and chambers of commerce very friendly when you start talking about bringing them a bunch of customers!

As president you become the point of contact for WBCCI headquarters, and traditionally (although not necessarily) represent the unit at the Delegates Meeting at the International Rally. I personally expect to be as cantankerous as I want to be, to encourage someone to be positively eager to replace me come the next election!




