


Reflections in Aluminum

Continuing last month's theme, "Things you should know".

We have **caravans** in WBCCI, in fact that was the primary reason for the formation of the club. Caravans can be formal or informal, and they tend to be more structured than rallies. A caravan usually involves several days (to several months) and multiple stops. For example, there have been Wisconsin Unit caravans to Alumapalooza recently. They were simply a scheduled group drive to the event, with the group stopping at a couple of places along the way. Nothing was provided besides traveling companions, nice evening conversations, and agreed upon stops on the way to our Airstream Mecca, the factory in Jackson Center, Ohio.

The caravans sponsored under the banner of the International club are anywhere from a few weeks to multiple months long. They usually include all camping fees, most ferry fees, detailed route planning, multiple meals, happy hours, tours, special admission to places that might be difficult to get into without a group. At first glance, the cost looks high, but let me assure you, they are significant bargains. Two years ago we were on the Alyeska Caravan to Alaska and nearby Canadian areas. It was 62 days, and cost \$6500 for two of us. I just checked, and another RV tour of 34 days is \$7500 for two. Clearly WBCCI offers a better bargain.

When I talk with folks about caravans, they give me a look like "What, travel with twenty five other trailers? No way, I am a loner." We normally spend our travel time in National Parks, State and National Forests, BLM Land and State and local parks. We wondered about caravans before we went on our first one. We found, that just like rallies, you will find people that you have a lot in common with and lots of fun things to do and see. The biggest thing you get, is into places you might not have access to as an individual and you get the opportunity to do things you didn't know you were interested in and you learn about the people, culture and area. You might end up riding along on a working crayfish boat, visiting the primary training boat for gulf oil workers, taking Glacier cruises, and meeting the best Cajun Accordion maker in the world. Try one of the caravans, you will find it fun, and with all the things included, much cheaper than traveling yourself.

Amendment No. 1

Proposed by: International Board of Trustees

Amend the Constitution by adding a new Section 3 to Article XI (Club Organization), Pages 5 and 6, as follows:

Sec. 3 Applications for Unit Charters outside of the present geographic areas of the established Regions shall be made directly to WBCCI Headquarters. The WBCCI Executive Committee may, upon being satisfied that the proposed Unit has complied with the minimum qualifications, issue the proposed Unit with a provisional charter. Supervision of these Units, once chartered, shall be as determined by the Board; however, representation of these Units at IBT Meetings may be by an existing Region President as assigned by the IBT. All other provisions of the Article shall apply.

Renumber the existing Sections 3 and 4 as 4 and 5.

Rationale:

With the augmentation of the expanded Airstream Company overseas dealer network and sales, it has already resulted in the formation of a WBCCI Unit outside of the North American continent. The present Constitution is not envisioned with this extension into the 21st century and this amendment would, at least, provide the groundwork for this and possible future overseas Units. This and additional procedures, as listed in the Bylaws, Article VI (Club Organization), pages 15 and 16, Section 5, will provide the basic procedures as we now best know them. Future modification may be necessary, primarily to the Bylaws, as WBCCI becomes more experienced with this concept.

March 18, 2014

As directed by the WBCCI Constitution, Article XVI, Sections 2 and 3, the recommendations of the WBCCI Constitution and Bylaws Committee for Amendment No. 1 are as follows: “This amendment is most necessary for the validity of our Club’s operations as both the Airstream Company and our WBCCI span of membership has expanded beyond the confines of the North American continent. It is highly recommended that it be accepted, and is suggested that the Delegates consider passage by ‘unanimous consent’ in order to reduce the number of roll calls votes from 4 to 3 in the 2014 Delegates Meeting”.

Amendment No. 2

Proposed by: International Board of Trustees

Amend the Constitution, Article XII, Section 2, page 6 by striking parts of two sentences and add the word “be”.

Sec. 2 The period for holding the International Rally and Annual Delegates Meeting shall “be” ~~include July 1, Canada Day, and July 4, Independence Day. If there is no suitable site available during such a period, the Executive Committee is authorized to approve a suitable site which is available~~ between June 20 and July 30.

The section would then read:

Sec. 2 The period for holding the International Rally and Annual Delegates Meeting shall be between June 20 and July 30.

This motion also includes amending Article XI (Club Organization), Section 2, sentence 3, page 5 by striking the words “Fourth of July” and adding “last day of the International Rally”

Sec. 2 Any such charter so issued shall terminate on the ~~Fourth of July~~ **last day of the International Rally** next following the date of its issuance unless terminated by action of said Board in granting or denying such application.

The sentence would then read:

Sec. 2 Any such charter so issued shall terminate on the last day of the International Rally next following the date of its issuance unless terminated by action of said Board in granting or denying such application.

Proviso: If adopted, this motion would be implemented in 2017.

Rationale:

1. Many members state that they would prefer to celebrate the holidays with their families. This would give the freedom needed to schedule the International Rally away from July 1st and 4th.
2. If the International Rally were scheduled after the holidays, more students and members with school related jobs would be able to attend.
3. This would give the International Vice Presidents more flexibility in searching for a future International Rally site as many qualified venues are reluctant to contract over the holiday time.

March 18, 2014

As directed by the WBCCI Constitution, Article XVI, Sections 2 and 3, the recommendations of the WBCCI constitution and Bylaws Committee for Amendment No. 2 are as follows:

“This amendment is designed to give the WBCCI Membership the opportunity to express their desires as to the dates of the International Rally. Contracts have already been authorized for the years 2014 thru 2016 which are date set; however, starting in 2017, dates for the International Rally will be per your decision. A vote NO means you wish the dates to remain as previous, a vote YES means you wish a date change from the International Rally including July 1 and 4. The portion of the Constitution stating the Rally dates between June 20 and July 30 will remain. The Amendment is appropriate for Delegate action”.

Amendment No. 3

Proposed by: International Board of Trustees

Amend the Constitution, Article VI, Section 2 B, page 2 by striking the lined through text.

Sec. 2 B. Ownership, except as otherwise provided herein, of a recreational vehicle manufactured by Airstream, Inc., as defined in this Article, and the payment of annual Unit and International dues to a Unit is prerequisite to retaining membership as a Regular Member.

The section would then read:

Sec. 2 B. Ownership, except as otherwise provided herein, of a recreational vehicle manufactured by Airstream, Inc., as defined in this Article, and the payment of annual Unit and International dues is prerequisite to retaining membership as a Regular Member.

The motion also includes amending Article XIV, Sec 2, page 7 by deleting the section.

~~The International Club dues of members, except Members at Large, shall be collected through the units of the club, and in the case of a unit in the process of formation, through the provisional unit and all International dues so collected shall be forwarded to International Club Headquarters. The International dues of Members at Large and the established surcharge shall be collected by International Club Headquarters.~~

Rationale:

Currently WBCCI requires each Unit to collect and send a member's International dues to Headquarters WBCCI. By allowing the payment of International and possibly Unit dues using an online system implemented on WBCCI.org, members will enjoy a new convenience and there will be an increase in efficiency for the Club.

March 18, 2014

As directed by the WBCCI Constitution, Article XVI, sections 2 and 3, the recommendations of the WBCCI Constitution and Bylaws Committee for Amendment No. 3 are as follows:

“This amendment is the first of a two, possibly three, step sequence to allow the annual dues of the WBCCI Membership to be collected thru WBCCI Headquarters. The amendment only specifies that dues would NOT have to be collected ONLY BY A UNIT for Regular Members. In order for this to become operational, this must be passed, then the new Headquarters Computer System must come fully on line, and considering the information in the February Blue Beret (Club News, page 22), each Unit desiring participation will have to take some action, all of which will be later specified and detailed. The amendment is appropriate for Delegate action, but note, passage will NOT automatically imply the immediate implementation of dues collection electronically by Headquarters”.

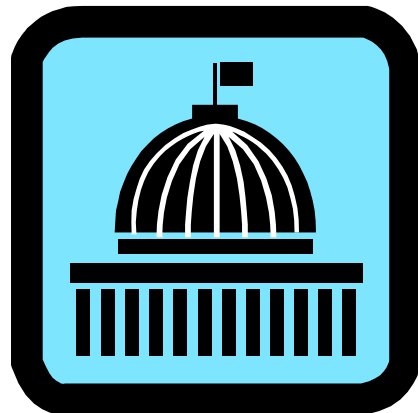

The business meeting will take place immediately following the luncheon, which begins at 11:30 AM. This will be an important meeting because we will be discussing proposed revisions to the WBCCI Constitution.

This ballot can be cast at the meeting, returned by mail, or emailed. (Blank ballots will also be available at the meeting.)

This ballot may be mailed to the Secretary of the Wisconsin Unit or voted at the business meeting.
